**Aaron Morrison (USA)** is a native of California's San Francisco-Bay Area and an award-winning New York City-based multimedia journalist, who uses words, video, audio, photography and social media to tell captivating stories across all platforms. As the *Miami Herald's* correspondent at the United Nations, he covers Latin America, the Caribbean and other issues impacting the Western Hemisphere. Aaron continually strives to expand his scope of knowledge and the number of countries he covers from the U.N. In the summer of 2013, he dove head first into coverage of the U.N. response to the Syrian crisis and other matters in the Middle East. A fellowship at the U.N.'s high-level conference on AIDS exposed him to international reporting. As an active member of the National Association of Black Journalists, the world's largest organization for professional journalists, Aaron actively promotes inclusion and opportunities for young, aspiring and early-career journalists in global and political reporting. Prior to the U.N. beat, Aaron was the politics editor for Loop21.com. He has worked with several U.S.-based news outlets, including The Associated Press and Gannett Company newspapers.



**Aktina Stathaki (USA)** is an artist, researcher and cultural practitioner with an interest in cultural diplomacy and intercultural exchange. She is the founder of Between the Seas Festival in New York City, a unique organization that presents and promotes contemporary performance from the Mediterranean and the MENA region in the US. As part of her work in the festival she has translated, presented and produced USA and world premieres from Greece, Lebanon, Algeria, Italy and more. She works regularly as a freelance director and producer for the theater and she is currently a Time Warner Fellow at the Women's Project Theater in New York. Aktina holds a BA in Communications (National University of Athens), a Diploma in Acting (National Theater of Greece) and a PhD in Drama (University of Toronto). She regularly writes articles and critical essays on contemporary theater and drama which have appeared in major conferences and publications worldwide. Aktina is a native of Greece and she currently lives in New York.



**Ben Allen (USA)** was elected as the top vote-getter in both his 2008 election and 2012 re-election; Ben Allen is a member of the Santa Monica-Malibu Board of Education and is the Board's immediate past President. Allen is an attorney with Richardson & Patel LLP, where his work focuses on government/political affairs and litigation. He is also adjunct faculty at UCLA Law School, where he teaches educational law and policy, serves on the executive board of the Los Angeles County School Trustees Association, is Vice Chair of L.A. County's Committee on School District Organization, and is a delegate to the California Democratic Convention. While in law school, Allen served as a voting member of the University of California's Board of Regents and as a judicial clerk with the International Criminal Tribunal for Rwanda. Afterwards, Allen was a litigator with the law firm of Bryan Cave and then led the successful L.A. launch of The Spark Program, a non-profit organization that connects at-risk middle school students with apprenticeships. Prior to his law career, Allen worked for the National Democratic Institute, and then as Communications Director for Congressman Jose Serrano (D-NY). Allen has degrees from Harvard, Cambridge and Berkeley, and is fluent in Spanish.

**Marc Serena (Spain)** is a freelance journalist based in Barcelona. He has been working in the most important Spanish media (TVC, RTVE, Catalonia Radio, Rac1, RNE, Avui, El Periódico de Cataluña) and several European media (Cafebabel, RTBF, Stradanove). He has covered multiple international events, as the latest Tunisian elections for the newspaper Público.

When he was twenty five he published “Trip to the 25” (2011), a snapshot of his generation that has been released in five languages including Chinese and Korean and named as one of the best travel books of 2011 by the Camino del Cid Award in Spain. His blog was awarded by Lonely Planet as the best non-English travel blog of 2009. During the same year, he was considered best Catalan blogger of the year.

He has travelled the African continent extensively and he has just published “Outing Africa” (2013), one the most comprehensive research so far about the LGBT community on the continent. He is currently co-directing a feature-length documentary shot in Cape Verde.

He has attended international events by the WHO Ministerial Conference on Environment and Health with the themes, “The future for our children” (Hungary, 2004) and the M100 Youth Media Workshop (Germany, 2012).



**Matthew Oresman (USA)** helps multi-national corporations and sovereign governments navigate complex, cross-border policy and trade matters, representing client interests before government entities in the United States, Asia, the Middle East, Africa and Europe. Oresman has significant complementary experience in international crisis management, and has worked on several high-profile matters of critical importance to corporate and sovereign clients. For example, in 2012, he managed international government and public relations for the Georgian Dream opposition coalition in its winning election campaign to take control of the Republic of Georgia’s parliament and government ministries. In 2011, he represented the Libyan National Transitional Council in its developing relationships with the U.S. government as it sought to oust the Qaddafi regime. Oresman also devotes significant time to pro bono work that leverages his international experience. In recent years, he has successfully lobbied to improve the way the United States combats HIV/AIDS around the world. Oresman earned his J.D at the Georgetown University Law Center and his B.A. at the University of Pennsylvania. He also studied at Tsinghua University and Fudan University in China.



**Mualla Cirakli (Cyprus)** currently works in the fields of foreign policy, democratization and human rights at the Service for Foreign Policy Instruments of the European Commission where she manages the EU’s election observation missions in fragile countries around the world.

Until 2012, Mualla served as the Head of the Brussels Office of the Turkish Cypriot Chamber of Commerce, which she set up in 2005. Liaising with EU institutions, NGOs and the public on national and European level, she voiced the values, interests and concerns of Turkish Cypriot people and the business community; with a view to further integrate them to the EU. In recognition of her achievements in this position, she was awarded the 2010 European Public Affairs Award as Rising Star of the Year.

Prior to joining the Chamber, Mualla worked at the Turkish Cypriot President’s Office as the Undersecretary’s Political Officer, closely dealing with the UN negotiations for the comprehensive settlement of the Cyprus problem. She also worked as a Trainer and Facilitator for the Cyprus Intercultural Training Initiative project funded by the UNDP to foster peace building, cooperation and trust between

**Renee Black (Canada)** is the founder of PeaceGeeks, a Canadian non-profit organization that helps grassroots non-profits to leverage web and mobile technology for promoting peace and human rights in developing and conflict-affected areas. Renee was inspired to start PeaceGeeks through her experiences connecting with grassroots groups working to advance peace and human rights, who often lacked basic tools to increase the visibility of the issues and strengthen their impact. She realized that skilled volunteers in areas like technology, design and communications, were passionate about contributing their skills and time to help these organizations to succeed, but didn't know where to get started. Their new open-source platform, Amani, will help partners to rapidly deploy new responsive websites, and collect and map critical issues affecting their communities. Renee previously worked as an IT Project Manager in the private sector, and later as a Policy Analyst for the Global Network of Women Peacebuilders, the UN Department of Peacekeeping Operations and UN Women. She volunteered with Habitat for Humanity South Africa on their ICT strategy, and interned in Vanuatu to help bridge the digital divide between the developed and developing world. Renee holds a Bachelor of Commerce (Honors) from Dalhousie University (1999) and a Masters of Public and International Affairs (Honors) from the University of Ottawa (2009).



**Steven Jacobs (USA)** is a digital communications strategist who specializes in political campaigns and online fundraising and organizing. He is currently the Email Programs Director at Blue State Digital in New York City, where he consults for international political campaigns, public health non-profit organizations, and civil rights advocacy organizations.
