**Ahmed Ibrahim (Egypt)** is the assistant of the high commissioner of the Egyptian Federation of Scouts and Girls Guides. Through his involvement with the Federation, Ahmed works with schools, universities, mosques and churches to engage children and youth into community service. Through environmental projects and social work, the Federation offers vocational trainings to youth with the aim of enabling them to become active members of their communities.



**Christine Goussous (Jordan)** is the country manager at Humanitas Technologies a startup based in San Francisco that leverages social media and AI to address philanthropic issues. In collaboration with local and international organizations, she is in charge of piloting Dandi, a social media app seeking to help nonprofits engage youths on issues within their communities, in Jordan and the MENA region.



**Khadeja Abuhaliqa (Qatar)** is a member of the Qatari Youth Counsel and a Youth Counsellor for the Ministry of Culture and Sports of Qatar, where she works on issues related to youth engagement and sports at local and international levels. 
education using his graphic design and photography skills.
